Aims and objectives

The ESF call for proposals aim to support a small range of strategic, regional projects to develop new ways of extending employment opportunities and raising workforce skills.

But remember.....

- This is not Equal
- Only three project per region (four in London)
- Projects will support Regional ESF Frameworks and Strategies
- Strong partnership dimension
- Collaboration not competition
- Strategic rather than individual or organisational benefits
- Strong emphasis on **Innovation**, **Transnationality** and **Mainstreaming**

Background

- Part of England and Gibraltar Operational Programme 2007-2013
- Dedicated innovative and transnational projects
- Operates outside of usual co-financing arrangements
- Menu of themes developed by ESF innovation, transnationality and mainstreaming sub-committee
- Regional ESF committees have chosen themes for their regions

Active inclusion

Aim

To facilitate labour market integration by;

- developing and testing integrated pathways
- mainstreaming innovative integrated new approaches
- disseminating active inclusion good practice
- tackling multiple disadvantage

Aim

To develop new ways of engaging employers to;

- enable ESF target groups improved access, retention and progression into and through work
- address employers' skills needs

Aim

Test and develop new ways of addressing the skills needs required to respond to the challenges of climate change and sustainable development

Indicative actions

- Training in environmental management

Demographic change

Aim

To test and develop new ways of addressing the employment and skills challenges of demographic change, with a particular focus on older workers and migration.

Indicative actions

Older Workers -

- Training and re-engagement
- Improving access to care
- Encouraging employers to support retraining
- Updating qualifications
- Promoting more flexible workplaces
- Training care workers to address skills gaps
- Using professional skills to help mentor SME's

Migration and integration

- Schemes for cross-referencing UK and foreign qualifications
- Supporting migrant workers to meet employer skills needs

Social enterprise

Aim

Promoting innovative actions in social enterprise to support the development of employment and skills opportunities.

Indicative actions

- Supporting employment of disadvantaged groups
- Developing leadership and management skills
- Developing impact measurement skills
- Training for new approaches to business growth
- Developing finance skills
- Identification of public sector contract opportunities and developing consortia
- Fostering careers in social enterprise

Innovation (1)

Innovation can be defined as the successful exploitation of new ideas ('Innovation nation', DIUS, 2008)

- In the context of ESF this can include new approaches, tools, methods and service provision to extend employment and raise skills.
- It can also mean adapting and applying existing approaches, tools, methods and services to new regions, sectors or target groups.

Innovation (2)

How can innovation be identified?

- **Why?** (what is the purpose of the innovation?)
- **What?** (what is the activity which forms the innovation and how does it resolve the problem?)
- **Who?** (who should be involved in developing and delivering the innovation?)
- **Where?** (where the location of the activity delivered can form the actual innovation)
- **How?** (how the activity is delivered can also form the innovation)
- **When?** (when the activity is delivered also impacts on success)

Transnationality (1)

Some core requirements;

- 5-15% of total budget must be dedicated to transnational activities
- All projects must have at least one transnational partner
- Past experience of working together is essential
- There are opportunities to secure additional partners
- Letter of intent is required with application form
- Successful projects will require a transnational agreement
- Added value must be demonstrated
- Complementarity with other funding and programmes

Transnationality (2)

Selecting your transnational partners;

- Build on past experiences (no more speed dating)
- Does not have to be another ESF project
- They must be able to add value at the thematic or strategic level
- Consider working with city or regional partnerships rather than individual organisations
- Consider 'tiers of co-operation' (who will work with whom?)
- Look for a clear track record or evidence of good practice, knowledge or experience in the thematic area

Transnationality (3)

Working together/Co-operation;

- Joint development of new activities
- Piloting, testing, transferring new ideas
- Thematic networking
- Study visits
- Thematic workshops
- Joint research and studies
- Work shadowing towards practice development
- Events, conferences and seminars

Mainstreaming

Mainstreaming can be defined as..

“the sharing and transferring of good practice, lessons learned and innovative areas of projects or programmes”

Things to consider

- Record the journey
- Develop a strategy
- Monitor progress
- Evaluate impact
- Disseminate results
- Identify links to influence policy and funding

Note:

The mainstreaming process is crucial. Be clear who? how? when? why? etc

Thematic networks

- Six in total, one for each theme
- Involve all ITM projects
- Involve key policy and decision makers
- Engage with other policy and thematic networks
- Facilitate cross-regional working
- Capture new learning and support mainstreaming
- Link with Equal Opps and Sustainability Sub-Cmttees
- Support the process of evaluation (link practice with policy)

Eligibility and guidance

- See extract from Manual 1, section 1.12 “innovation and transnationality”
- Outlines eligible and ineligible costs
- Some issues to remember;
 - match funding requirements. Private sector match funding is not eligible
 - staff costs cannot be included in transnational budget
 - cannot pay costs of transnational partners but can pay for external ‘experts’
